Cost includes a non-refundable \$750 deposit per person which is required along with the signed waiver to reserve your spot. The deposit has to be paid online.

Once you've reserved your spot, we will send you an invoice for the remaining balance which is due by January 7, 2024.

LATE REGISTRATION

Participants may register after January 7, 2024, space permitting; however payment in full is required at time of registration.

PACKAGE PRICE INCLUDES:

- Breakfast daily + one additional meal daily
- At Borgo Pianello, all meals and classes (cooking and yoga)
- Transportation including train tickets and private buses

- Taxi rides between Bologna airport and hotel
- Alcoholic beverages
- Snacks
- Any items of a personal nature

The Organizers of Bologna 2024 (Danielle Tait and Isabella Dellolio) reserve the right to make any changes to the itinerary that is determined as necessary, with or without advance notice. Changes in the itinerary will not incur extra charges to the participants or result in a refund for any portion of the trip price.

CANCELLATION POLICY

All requests for cancellation must be submitted in writing by email to the trip organizers at info@danielletait.com and isabella@isabelladellolio.com by the dates listed below.

Regardless of the reason, cancellations result in additional costs and processing time for the trip organizers, as such all cancellations are subject to a cancellation fee.

MORE THAN 90 DAYS PRIOR TO START DATE:

\$100 cancellation fee plus \$750 deposit forfeited.

LESS THAN 90 DAYS PRIOR TO START DATE:

\$150 cancellation fee plus \$750 deposit, and full balance forfeited.

PLEASE NOTE: Due to these uncertain times due to the COVID-19 Pandemic all participants are REQUIRED to purchase Travel Insurance which will fully cover the cost of the trip (as well as the cost of airfare) in the event the trip needs to be canceled due to increased risk in the country being traveled to or if you are unable to attend due to illness. Be sure to purchase a policy that offers coverage "for cancellation for ANY reason". We recommend purchasing travel insurance through Trawick International (trawickinternational.com) or World Nomads (worldnomads.com). The cost of travel insurance is quite reasonable and offers excellent coverage along with peace of mind. Please be aware that the insurance offered by your airline upon booking is NOT the same as Travel Insurance!

If the participant leaves the trip for any reason prior to its conclusion, refunds will not be made for the unused portion of the trip.

No refunds will be made for any excursion, meal, yoga class, workshop, etc... or other activity that the participant misses or decides not to participate in for any reason.

This trip is subject to a minimum enrollment of 10 participants and a maximum of 12 participants. The trip organizers reserve the right to cancel the trip prior to departure. If such a cancellation is NOT due to circumstances beyond the trip organizers control, such as war etc, as set forth below, the trip organizers will refund all payments, constituting full settlement with the participant. No compensation will be made when cancellation arises before or during the trip from circumstances beyond our control (force majeure) such as war, strife, civil disobedience, strikes, terrorist activity, adverse weather conditions, fire, natural disasters, etc., unless or until the trip organizers are able to recover any trip related sums. In the event of cancellation arising from circumstances beyond our control, as set forth above, trip related sums recovered by the trip organizers will be distributed equitably to the participants after the trip organizers deduct all out of pocket costs and related expenses.

It is required that participants purchase their own trip insurance. The trip organizers are not responsible for expenses, including but not limited to, lodging, meals and transportation incurred for delays and/or detainments beyond the trip itinerary as a result of circumstances beyond our control such as COVID-19 upsurge, war, etc., as set forth above.

NATURE OF THE TRIP

This is a group vacation for anyone age 18 and older. Accordingly, participants are strongly encouraged to fully attend all of the offerings provided. All participants are encouraged to approach the trip with a positive spirit, sense of adventure and self-discovery.

Smoking is **NOT** permitted in vans, cars, at meals, inside buildings or when we are gathered as a group.

PASSPORT AND VISA

A passport must be obtained in advance. Each participant is responsible for determining their specific passport requirements and for obtaining the necessary documents prior to departure.

If you already have a passport, double check the expiration date and be sure it is not set to expire six months prior, during or six months after the trip date. If so, renew it prior to the departure date.

A Visa is NOT required for Italy.

MEDICAL INSURANCE

For your own safety, well being and financial protection, it is essential that you are adequately insured. Each participant is responsible for checking with their current health insurance provider and ensuring that they have adequate medical coverage. Participants must carry insurance documentation while on the trip.

MEDICAL PROBLEMS/DISABILITIES

If you have a medical condition or disability which may affect your participation, you must inform us before confirming your booking so that we can advise as to the suitability of the chosen trip. You must also provide us with full details in writing at the time of booking and notify us of any changes or deterioration in the disability or medical condition or development of any disability or medical condition after booking.

We reserve the right to decline any booking or cancel (in the event of the development, deterioration or change of any disability or medical condition occurring after confirmation) whenever we reasonably feel unable to accommodate the needs of any particular participant or we feel that the participant could be in danger.

TRAVEL INSURANCE

It is required that you purchase travel insurance. Travel Insurance is not the same as the insurance offered by your airline upon booking. This insurance should cover trip cancellation/interruption, lost luggage, delays etc. Be sure that the insurance you purchase has adequate coverage and will cover the costs in the event of necessary quarantine due to COVID-19. We recommend purchasing travel insurance through Trawick International or World Nomads.

As a participant of the Bologna 2024 trip, you agree to the organizers, the using of photographs or video from the trip in its advertising or publicity materials without any further consent.

RELEASE/RESPONSIBILITY - WAIVER OF LIABILITY

The participant, by signing this Participant Agreement, agrees that the trip organizers and it's representatives, shall not be held liable for any injury, damage, loss, delay, or irregularity that may be occasioned for any reason, including but not limited to any defect in a vehicle, the acts or default of any company or person engaged in conveying a participant, acts of God, terrorism, acts of war, or detention; delays or expenses arising from quarantine, strikes, thefts, pilferage, force majeure, civil disturbances, government restrictions or regulations, accidents by aircraft, boat, bicycle, or motor vehicle, or in any restaurant or accommodation; failure of any means of transportation to arrive or depart as scheduled or changes in transit, missed airline or other transportation connections; or for additional expenses resulting from changes in exchange rates, tariffs or itinerary.

The participant agrees to assume all risks associated with the trip and agrees that no liability will attach to the trip organizers, it's employees or agents, or to any member of of the trip in respect of death, personal injury, illness or delay of the passenger, or for any loss of or damage to the property (including luggage) of the participant during the course of the trip, howsoever caused.

By signing this Participant Agreement, the participant releases the trip organizers and its representatives from any such responsibility or liability.

It is required that participants purchase travel insurance that covers cancellation, property damage (including luggage), accidents and medical expenses/quarantine lodging costs due to COVID-19.

For the benefit of everyone on your trip, the trip organizers reserve the right to accept or reject any trip participant at any time without liability, and in the event it determines, in its sole and exclusive discretion, that if a participant is disruptive to the harmony of the trip it may without any obligation to pay a refund or any other amount whatsoever, expel such a participant from the trip. The trip organizers will have no responsibility or liability for any participant who leaves the trip prior to its conclusion or for any activity undertaken by any participant which is not included in the trip itinerary.

In making this booking, you acknowledge and understand the extent of this contract and hereby absolve and hold harmless Danielle Tait Photography and Isabella Dellolio Photography, Danielle Tait and Isabella Dellolio and any other parties connected in any way to the organization of this trip.
